

FRESH MUSIC LIBRARY LICENSING AGREEMENT

1. FRESH Music Library (licensor), does hereby grant to Charlie Whathisname / The Company LLC, 10 Any St., Anywhere, AK, 00000 (licensee), the non-exclusive right to mechanically reproduce and/or synchronize to film, video, web, YouTube (including monetization) or audio productions, the musical compositions contained within the FRESH Music Library theme(s) or disc(s) -- **Names of Track or CD's** -- whose exclusive rights and/or copyrights are held and controlled in whole by Buncha Punks Music, Joodle Music, Rennisauce Music (ASCAP) and Concotal Music, BeJoodle Music (BMI) DBA The FRESH Music Library.

2. Licensee recognizes that this non-exclusive mechanical and or synchronization license shall be limited to the lifetime of the licensee.

3. The rights and license granted hereunder may not be assigned or transferred, either affirmatively or by operation of law, without the written consent of FRESH Music Library.

4. This license does not include the right to use the musical compositions of the FRESH Music Library as performance or foreground music. The licensee has only the right to use the musical compositions of the FRESH Music Library as accompaniment to, or set-in synchronization with, another form of media (i.e. video, narration, slide presentations, etc.), and may sell products containing said synchronizations which they have created but not as a "performance" piece unto itself. The right to reproduce and/or resell the musical compositions of the FRESH Music Library as performance or foreground music unto themselves is also prohibited. A separate "performance" license may be obtained by contacting FRESH Music Library directly.

5. Licensee may not, without obtaining the prior written consent of Fresh Music and the payment of additional License Fees: (i) include the Licensed Material in an electronic template intended to be Reproduced by third parties including, without limitation, in a product or service that enables an end user to create soundtracks, in a system that resells products that include the Licensed Material, or in any "build-it-yourself" media tools; (ii) use or display the Licensed Material on websites or in any other medium designed to induce or involving the sale, license or other distribution of "on demand" products, including, without limitation, electronic greeting cards, voicemail greetings, ring tones, multi-media albums or presentations, or similar items; (iii) use or display the Licensed Material in an electronic format that enables it to be downloaded or distributed via mobile or wireless devices or shared in any peer-to-peer or similar file sharing arrangement; (iv) use the Licensed Material as a component of a larger musical composition, including but not limited to "sample-based" musical productions; (v) use the Licensed Material to manufacture, distribute or sell audio-only products, whether in the form of compact discs (CD's), cassettes, phonographs, digital downloads or any other format or media now known or hereafter devised; (vi) sub-license, re-sell, rent, lend, assign, gift or otherwise transfer or distribute the Licensed Material or the rights granted under this Agreement; (vii) manufacture or distribute more than one thousand

(1,000) units of the Licensee Work; or (viii) in the case of in-store, in-office or on-hold background music, use the Licensed Material in more than two (2) physical locations.

6. If the Licensed Material is reproduced on a website, Licensee shall post terms and conditions on the website that include restrictions on downloading the Licensed Material for other than personal use, and prohibit republication, retransmission, reproduction or other use of the Licensed Material. If the Licensed Material is Reproduced on a social media platform or other third party website, (i) the rights granted herein shall automatically be revoked in the event that the platform or website seeks to exploit purported rights to the Licensed Material contrary to the terms of this Agreement, and (ii) in such event, upon Fresh Music's request, Licensee shall remove any Licensed Material from such platform or website.

Buncha Punks Music, Joodle Music, Rennisauce Music (ASCAP) and Concottal Music, BeJoodle Music (BMI) DBA The FRESH Music Library warrant only that we have the legal right to grant this license and this license is given and accepted without warranty or recourse. The total liability of Buncha Punks Music, Joodle Music, Rennisauce Music (ASCAP) and Concottal Music, BeJoodle Music (BMI) DBA The FRESH Music Library under each license is limited in any event to that part of the consideration paid to Buncha Punks Music, Joodle Music, Rennisauce Music (ASCAP) and Concottal Music, BeJoodle Music (BMI) DBA The FRESH Music Library by the licensee.

9. Domestic and International broadcasts of this music must be cleared through either [ASCAP](#) or [BMI](#), depending upon affiliation of each composition, whose revenues are collected directly from the broadcast station licensing, NOT from you as the producer. If your production is to be broadcasted you or the broadcaster are required to file a cue sheet with either [ASCAP](#) - cuesheet@ascap.com or [BMI](#) - cuesheets@bmi.com. There is no extra charge to you the producer.

10. This agreement may not be modified orally and shall not be binding or effective unless and until it is signed by both those parties hereto.
